Candidates must be able to clearly articulate their ability to deliver services to historically marginalized members of the community. This position will support a new program and will focus on serving new and expectant parents. This position is required to attend training and successfully complete their certification in Perinatal Mental Health as a condition of their probationary period with the agency (More information can be found at <https://www.postpartum.net/professionals/certification>).

Duties and Responsibilities

- ❖ Provide mental health and/or substance abuse counseling to individuals, couples, and families, with a special focus on new/expectant mothers and their partners/support people.
- ❖ Conduct counseling in various settings including, but not limited to: Clinic office, offsite at other partner agencies, and virtual
- ❖ Conduct assessments and evaluations to determine diagnosis using DSM-5 TR criteria.
- ❖ Identifying treatment goals and develop holistic treatment plans.
- ❖ Implement evidenced-based treatment modalities to appropriately address diverse client needs.
- ❖ Continually assess client progress while tailoring approaches to individual needs.
- ❖ Collaborate with clients' family members, loved ones, and other service providers when necessary.
- ❖ Record and maintain records, medical documentation, and appointment schedules. Collect outcome data. Provide resources and referrals for client needs.
- ❖ Communicate with referring and partner agencies.
- ❖ Effectively use digital technology platforms (electronic medical records, telehealth, IP phone applications, etc.)

Minimum Qualifications

- ❖ Master's in Social Work, Professional Counseling, or similar degree from an accredited university program.
- ❖ Demonstrate complete alignment with the agency's mission, vision, and values.
- ❖ Licensed in Wisconsin as an APSW, LPC-IT, or as a LCSW, LPC or LMFT.
- ❖ Experience providing culturally sensitive mental health treatment and/or working with diverse populations.
- ❖ Experience providing care to individuals, couples, and families.
- ❖ Excellent interpersonal communication skills.
- ❖ Proven relationship-building skills with individuals from diverse backgrounds.
- ❖ Experience working collaboratively with partner organizations.

Preferred Qualifications

- ❖ Two years' experience working with people or families in the perinatal/postpartum period, in any capacity (case manager, therapist, etc.).
- ❖ Experience running groups or developing group curriculum/materials.
- ❖ Bilingual with the ability to provide services in multiple languages.
- ❖ Experience working with third party interpreters.
- ❖ Wisconsin licensure as an LCSW, LPC, or LMFT.
- ❖ Experience providing counseling to clients ages 4+ years old and families.
